The Streamlined Sales Tax Agreement, a multi-state agreement providing for the simplification of the nation's varying sales tax laws. These states include: Indiana, Iowa, North Dakota, South Dakota, Tennessee, and Wyoming. In accordance with the Agreement, the procedure for obtaining an exemption from sales tax on the basis of diplomatic or consular status remains similar to previous procedures.

### **Streamlined Sales Tax Exemption Certificate**

The FairTax is a proposal to reform the federal tax code of the United States. It would replace all federal income taxes (including the alternative minimum tax, corporate income taxes, and capital gains taxes), payroll taxes (including Social Security and Medicare taxes), gift taxes, and estate taxes with a single broad national consumption tax on retail sales.
